# INTRODUCTORY WORD

I've always wanted to do things I enjoy, but I also wanted to be a little useful. I liked to pass on my observations to my surroundings, friends, acquaintances, or classmates. I always learned something new from them. My interests have always been quite broad. I like to sing, dance, but I also cook. Moreover, I've always been very interested in what was going on around me. I have always thought about the essence of things and how they work. I have dealt with politics, economic context, and society. I have been interested in problems in different parts of the world, but also in the concerns of ordinary people in the neighbourhood. When I was about to choose a university I would attend after graduation, the Faculty of Economics was a clear choice. I felt that this was the kind of social field that would connect my broader interests and I would get to understand not only the economic principles, but also the society as a whole. I liked going to school, but I participated in student life too.

I think that my alma mater brought me a lot. Yet, already during my studies, I began to doubt whether all things were as they should be. It seemed to me that sometimes we studied unnecessary subjects, knowledge was not always purposefully interconnected, and some of our teachers paid less attention to us and solved their own problems. A thousand students in a year meant that sometimes we were just numbers that were hard to wade through in the crowded corridors. Later, I went on to further studies at the Faculty of Law. Another university, another city. And everything was similar. There were teachers with whom I got along and who had time for me. We hung out at school and beyond. But there were more of those who had no time, oral exams were gradually cancelled, and things became routine. Study, pass the test and go home. Many of my classmates resigned, even though they had many ideals at first. They resigned from learning something, thinking, being interested in what was happening around him. They became pragmatists. Finish your studies, get a degree and get a job. I told myself that this was the life. There was probably no other way. There were good things and then there were bad things. This was probably higher education and maybe not only in our country. After finishing my university studies, I, like others, tried to take the usual routes, concentrating on legal practice. I also completed my doctoral studies in the field of economics.

At that time, I met a group of enthusiastic people who were trying to think about where school education was going. They often discussed it into the night. I found out that my teachers or classmates from university studies were among them. We dealt with issues of the Czech public education system, stereotypes in primary or secondary schools. We have often passionately discussed where memorization led to, why schools were the same as they had been two hundred years ago, why they did not develop critical thinking and killed creativity. But we didn't just sit in pubs and complained. We tried to do something about it. We decided to run our own schools and tried to implement our ideas in practice. We have defined clear principles and values on which our schools should be built and where they should go. We founded PRIGO. Gradually, we have built many different schools, grammar schools, elementary schools and several others. All of them were built on clear values and visions. Most of the time it wasn't easy. The surroundings didn't like us, competing established schools or state authorities.

I participated in the formation of the concept and in the development of PRIGO schools. I often wondered if it was enough, if I could not go to less explored territory and in the direction of changes in the way of teaching and functioning in the sometimes-hostile environment. To universities. For many years, there have been discussions about alternatives in primary or secondary education. But new concepts in higher education are not noticeable. Big universities tend to do things in the same way as a century ago, or even as in deep history. I do not mean laboratory equipment, procedures, but a way of thinking and functioning. My friends not only from PRIGO supported me, so I became a spiritual mother and rector of PRIGO University. A private, non-profite school. A school whose goal is not to generate profit, but to generate quality and satisfaction. I wanted to break down established ideas about how a college must work. I wanted to break down myths about the poor quality of private universities. After all, abroad, private universities are almost always the best ones.

I approached equally enthusiastic people and we started to build a university together. A small one, with a family character. As in private kindergartens or elementary schools, where a small number of children in classes is common, so we involve students in groups whose members you would count on the fingers of both hands. We really dedicate ourselves to students and involve them from the beginning in all activities. Each student has his own mentor with whom he can consult his school or private problems. I think we are a family. However, this does not mean that we do not place the necessary demands on each other, quite the opposite. Together we strive to develop our competencies and opportunities for future employment and life. We want to be the best. But not with a tic in an eye. Of course, we have problems, but we always try to solve them. Of course, we make mistakes, but we try to learn from them. I think that together with our students, we always experience five wonderful years of life.

I'm glad I could make my dream come true. Doing things that I enjoy and being beneficial. I have a vision to build a university that its graduates will be proud of. A school that will give them everything for their future life. I feel like we're doing well. And I am pleased that I am not alone and share the same values and direction with my colleagues and friends.

# STUDY PROGRAMMES

#### BACHELOR STUDY PROGRAMME | ECONOMY AND MANAGEMENT (Bc.)

The aim of the three-year study programme Economy and Management is to prepare graduates who understand the structure and functioning of any type of economy and are able to manage it using modern management methods. It is therefore the study of the management of the economy regardless of its size, affiliation to the private or public sector, profit or non-profit nature, legal form, national, international or transnational character, etc. The content focus of the programme thus creates the prerequisites for graduates to be employed in various managerial positions in the private and public sector, i.e. in enterprises, multinational corporations, internationally operating companies, authorities, local government bodies and other organisations in the public or non-profit sector. The study programme provides theoretical knowledge in the field of microeconomics, macroeconomics, management and the structure and functioning of the economy of a company, the Czech Republic and the world. Through compulsory elective courses, students have the opportunity to profile themselves more closely in the management of sub-types of the economy. During their studies, they acquire the professional knowledge and practical skills necessary for the practice of management, as well as linguistic competence. Thanks to this, they will be prepared for further studies or employment not only in the Czech Republic but also abroad. Part of the study includes the completion of professional practice, but the study programme is designed as an academically oriented programme representing the basis for further master's studies in management and administration-oriented programmes.

The graduate of the Bachelor's study programme Economy and Management will be employed mainly as:

- · corporate manager,
- · financial and project manager,
- · manager in international and multinational corporations,
- manager in the public sector and in the non-profit sector,
- · businessman.







#### BACHELOR STUDY PROGRAMME | ECONOMIC POLICY AND PUBLIC ADMINISTRATION (Bc.)

The aim of the study in the three-year programme Economic Policy and Public Administration is to prepare graduates equipped with the competences for qualified performance of an independent worker in the economic policy field, especially in the monetary field, in banking and insurance, in EU bodies and institutions, in state administration and self-government bodies, or in business management in the private sector. The study programme provides theoretical knowledge in the field of economic theory, as well as in the area of economic policy objectives, tools and authorities, both at general level and in specialized areas such as fiscal policy, monetary policy, social policy or employment policy. The programme also provides theoretical knowledge and practical skills in the field of public sector functioning, including its management and financing. Part of the study is the development of language skills so that graduates can apply them both in the follow-up study and in practice. Part of the study is also the completion of professional practice, but the study programme is designed primarily as an academically focused programme, which forms the basis for the follow-up master's degree in programmes focusing on economic policy and administration.

The graduate of the Bachelor's study programme Economic Policy and Public Administration will be employed in particular as a specialist:

- in central bank, commercial banks or insurance companies,
- in the bodies of EU institutions and other international organizations,
- in state administration bodies and in bodies of self-governing units,
- in lower and middle management of private sector enterprises.



#### MASTER'S DEGREE PROGRAMME MANAGERIAL ECONOMICS (Ing.)

The two-year follow-up Master's degree programme in Managerial Economics is focused on the application of economic theory and methods in the process of managerial decision-making at the level of the private and public sectors of the economy. The aim of the study in this programme is to prepare graduates who will be equipped with highly specialized knowledge in the field of Managerial Economics serving as the basis of original thinking or research and will be able to critically realize knowledge in this field and at the interface between different areas. Graduates will also acquire special skills required in solving problems in research or innovation in order to develop new knowledge and practices and integrate knowledge from various areas of Managerial Economics. In accordance with EQF 7, graduates will also be able to manage and transform work or study contexts that are complex, unpredictable and require new strategic approaches, and be responsible for contributing to professional knowledge and practices or assessing the strategic performance of teams.

The graduate of the follow-up Master's study programme Managerial Economics applies as:

- corporate manager, especially financial and project manager, strategic level,
- manager in international and multinational corporations, middle and top level.
- manager in the non-profit sector, in the public sector, middle and top level,
- entrepreneur.

# MASTER'S DEGREE PROGRAMME ECONOMIC POLICY AND PUBLIC ADMINISTRATION (Ing.)

The graduate of the two-year follow-up programme Economic Policy and Public Administration is prepared to work as an independent economic expert and analyst, able to carry out national economic analyzes using advanced statistical and econometric methods, taking into account the broader macroeconomic context and patterns of socio-economic development of society. Other positions of graduates of the study programme are positions at the level of middle and top management both in public administration institutions and in the private sector, where they are able to lead a team, including a team with an international composition. The graduate can also work as a project manager in both the private and public sectors, where he / she is able to process and evaluate grant applications. In all positions, the graduates will use the language skills acquired during their studies through lectures by foreign teachers, work with foreign language literature or through a foreign internship.

The graduate of the follow-up Master's study programme Economic Policy and Public Administration will be employed as a professional analyst or manager in the following types of institutions and organizations:

- banking and insurance (central bank, commercial banks, insurance companies and other financial institutions),
- bodies of EU institutions and other international organizations,
- public administration and non-profit sector (central government and self-government bodies, labour offices, social security administration, tax authorities, statistical offices, etc., nongovernmental non-profit organizations),
- private-sector firms (enterprises operating in all sectors where graduates find work both as professional economic analysts and in middle and top management).

# TUITION AND SCHOLARSHIP




The standard tuition fee for students admitted on the basis of second or other rounds of admissions is CZK 9 990 per month (12-month payment) or CZK 99 900 per year in the case of a one-off payment.

However, students admitted in all these remaining rounds of admissions may draw scholarships from the social programme for talented students. The application must demonstrate exceptional talent, based on the results of the admissions procedure, and document a difficult socio-economic situation.

The promotion for tuition-free studies, which was used by students admitted on the basis of the first round of admissions, has already been closed.

Students admitted in all rounds of the admission procedure may receive additional merit or research scholarships. At the same time, they will receive free modern equipment from us, including an iPad, which they can use not only at school but also in their free time.



# PREPARATION FOR MASTER'S STUDY ABROAD

Students who start studying our bachelor's degree programmes have the opportunity to complete the unique Competences for Master's Degree lifelong learning programme. This programme systematically prepares our students to study in master's degree programmes at prestigious universities in the United Kingdom, the US and other countries, where they can continue with their studies after successfully completing the bachelor studies with us. This programme is intended for talented and particularly motivated students from the Czech Republic who want to obtain a high-quality education abroad and the associated assurance of employment in prestigious jobs. Master's degree studies, especially at universities in the United Kingdom and the US, usually last two years; or one year only in some cases. The admission procedure is specific, though most of its relevant parts can be prepared for very well. The preparation at PRIGO University takes place on two levels. Above all, it concerns the style of teaching at our university, which, within legal possibilities, focuses on the use of modern teaching methods comparable

to prestigious foreign universities. At the second level, we offer our students to take part in the unique Competences for Master's Degree (CMD) programme, which we have prepared so that it can systematically prepare students beyond the scope of studies in accredited bachelor's programmes for the admission procedure and the studies in prestigious master's degree programmes at foreign universities. Students are led as part of this programme to participate in volunteer and extracurricular activities, as participation in these activities is often required by foreign universities in the admission procedure. As one of the few in Czechia, the PRIGO University participates in the prestigious Duke of Edinburgh (DofE) programme, which was founded in the UK. Within the CMD programme, our students will be meeting successful graduates of foreign universities, such as the University of Oxford, the University of Cambridge or Harvard University. The programme also includes a visit to the above-mentioned prestigious schools and a meeting with their students and teachers


The Czech Economic Society (CES) based in Prague is the most important economic organization in our country.

The journal has been published by the De Gruyter, a prestigious publisher with a history of almost 270 years, since 2021 in collaboration with the PRIGO University. It is printed, but in particular it is published and distributed as an electronic Open Access resource. It is listed in most key citation databases, while it has been listed in the Scopus database since 2010.



# **CONFERENCE**

The International Scientific Conference Economic Policy follows the long tradition of conferences held in the Moravian-Silesian Region subtitled as Economic and Social Challenges of the European Economy, Economic Policy in the EU Member Countries, Economic Policy and New EU Member Countries, and Economic Policy and Economics in Transition. The conference takes place in the Moravian-Silesian Beskydy Mountains and is attended by experts in the disciplines of economics, law, social and political sciences and international relations – coming from the Czech Republic as well as from abroad.
