## FEES AND TUITION FEES REGULATION of the European Research University

#### Art. 1

#### **Introductory provisions**

- 1. In compliance with the provision of Art. 1 of the Statutes of the European Research University, this Fees and Tuition Fees Regulation is issued as an internal rule of the European Research University.
- 2. This Regulation provides the conditions for making payments at the European Research University (hereinafter referred to as 'ERUNI'). The payments mean the fees listed in Art. 2 and the fees for studies (hereinafter referred to as the 'tuition fees') listed in Art. 3.
- 3. The fees are always set for a relevant academic year. The specific payment method and the amount of fees are always determined by the decree of the Rector of ERUNI before the beginning of an academic year.
- 4. The specific payment method and the amount of tuition fees for study applicants are determined by the decree of the Rector of ERUNI no later than on the day on which the admission conditions are announced. The applicants accept the above-mentioned proposal by enrolling for studies. Details can be adjusted contractually.

### Art. 2

### Fees

The following fees may be established at the ERUNI:

- a) fee for the operations associated with the admissions to an accredited study programme,
- b) fee for the operations associated with the admissions to a lifelong learning programme,
- c) administrative fee for the enrolment,

- d) fee for extending the study period,
- e) fee for resitting an exam or diploma exam,
- f) fee for a subject recognition or for performing a differential examination,
- g) fee for issuing a student certificate,
- h) fee for issuing a copy of academic diploma,
- i) fee for a statement of grades,
- j) fee associated with the request for an individual study plan.

#### Art. 3

#### **Tuition fees**

- 1. The following payment methods of tuition fees may be established at the ERUNI:
  - a) tuition fees per semester of studies in an accredited full-time study programme,
  - b) tuition fees per semester of studies in an accredited combined study programme,
  - c) tuition fees per semester of studies in a lifelong learning programme.
- 2. The tuition fees may be set separately for studies in Czech or in a foreign language, if the ERUNI or any of its organisational units listed in Article 3 (1a) of the Statutes of the European Research University realises the studies in such languages.
- 3. Students are required to pay the set tuition fees according to the conditions stated in the relevant Rector's decree.
- 4. The tuition fees per given semester can be divided into instalments. The amount of instalments and their maturity are determined by the Rector of ERUNI.
- 5. Based on a student's request, the Rector of ERUNI may decide that the particular tuition fee be reduced. The reduction of tuition fee may be decided by the Rector of ERUNI due to excellent study results or other relevant reasons. There is no legal claim to reduce tuition fees.



6. If a student does not pay their tuition fees properly and in time, such action constitutes a disciplinary offence as defined in Art. 64 of the Higher Education Act. The sanction for such disciplinary offence is expulsion from studies as per Art. 65 (1c) of the Higher Education Act. A disciplinary action is not mandatory in this matter. The outstanding amount will be subsequently passed on for debt collection.

#### Art. 4

#### **Final provisions**

- This Fees and Tuition Fees Regulation was approved by the Board of Directors on 22 September 2023.
- This Fees and Tuition Fees Regulation supersedes the Fees and Tuition Fees Regulation of the PRIGO University registered by the Ministry of Education, Youth and Sports on 31 August 2021 under File No. MSMT-21630/2021-5.
- 3. In compliance with Art. 36 (4) and Art. 41 (2) of the Higher Education Act, this Fees and Tuition Fees Regulation comes into force on the day of registration by the Ministry of Education, Youth and Sports and into effect on the day following the day of registration.
